

Sir,

Permission is granted provisionally to open Std. VIII in your school from June 1971 subject to fulfilment of the following conditions before opening of the school for the ensuing academic year.

(1) A trained graduate with five years teaching teaching experience in Secondary Schools, out of which at least two years should be post training service, is appointed as Head Master of the school.

(2) A trained science graduate (B.Sc.B.Ed) is appointed.

(3) The services of qualified teachers such as Sr./Jr. H.S.S., D.T.C. /C.P.Ed. are secured.

(4) Adequate furniture and equipment such as dual desks, black boards, tables, chairs, work tables etc. of approved patterns, sets of science apparatus and Physical Education Equipment are purchased.

(5) Necessary additional teaching aids etc. are provided.

(6) Rs. 500/- is spent on the purchase of library books (for teachers and pupils)

(7) Satisfactory accommodation for class rooms, science laboratory, with proper ventilation and lighting is provided.

2. It should be noted that the proposed higher stds. should not be opened unless all the conditions laid down in para 1 are fulfilled. If the conditions are not filled, the provisional permission now granted, may not be confirmed. A detailed report regarding the fulfilment of these conditions should be submitted to this office on or before 20.6.71




