**Following points were discussed**

**CHANGE IN SCHOOL UNIFORM-** From the academic year 2022-23 SSRVM Bhugaon will follow the SSRVM Trust prescribed school uniform for both girls and boys. This is for the purpose of uniformity and the convenience of the students joining SSRVM schools all over India.

This also includes P.T. uniform (i.e., House colour T shirts with regular track pants).

Details about school uniform (size and cost) will be sent later to all the parents.

The students of Std 10<sup>th</sup> will continue with their old uniform for the academic year 2022-23.

**2) SCHOOL REOPENING-** EPTA members were informed that as per the GR received from the Maharashtra government in the last month, the school will be reopening for Std 10th on 12th Oct, and for Std 9th after Diwali vacations. And thereafter for Std 5<sup>th</sup> to 8<sup>th</sup>. All the prescribed Covid-19 norms will be followed by the school.

Hybrid model of schooling will be followed.

The school will be providing the transport facility for those attending the school physically.

By 15th Oct a detailed circular regarding the reopening of the school will be sent to all the parents.

**3) REVISION OF SCHOOL FEES-** As per the Maharashtra Education Act, 15% fee hike on the current fees was approved by all the members for the academic year 2022-23.

Date-Monday, 10<sup>th</sup> July, 2023   Time- 8.30 to 9.30 a.m.

The 2<sup>nd</sup> EPTA meeting was conducted on Monday, 10<sup>th</sup> July 2023 in Bhugaon school.

The Meeting began by chanting ' Omkar'.

Principal Mrs. Sangeeta Das welcomed all the EPTA members and presented the agenda of the meeting.

**The following points were discussed in the meeting.**

- **Rectification of the School fee Structure:**

School had made rectification in the fees which was approved by the EPTA members on 20<sup>th</sup> May 2023. After which a few parents requested gradual implementation of the rectified fees. So, the school had conducted a poll where the majority of the parents selected Option 2. After which, as per the request of a few parents, the School Management agreed unanimously to go for the modified Option 2. This will include a discount of Rs 2000/- per year till 2025-26.

The EPTA members present at the meeting held on 10<sup>th</sup> July 2023, agreed to the proposal to proceed with the implementation of the fee rectification plan with the modified Option 2. EPTA members also agreed that the late fee be charged after the due dates of the Fee Installments.
