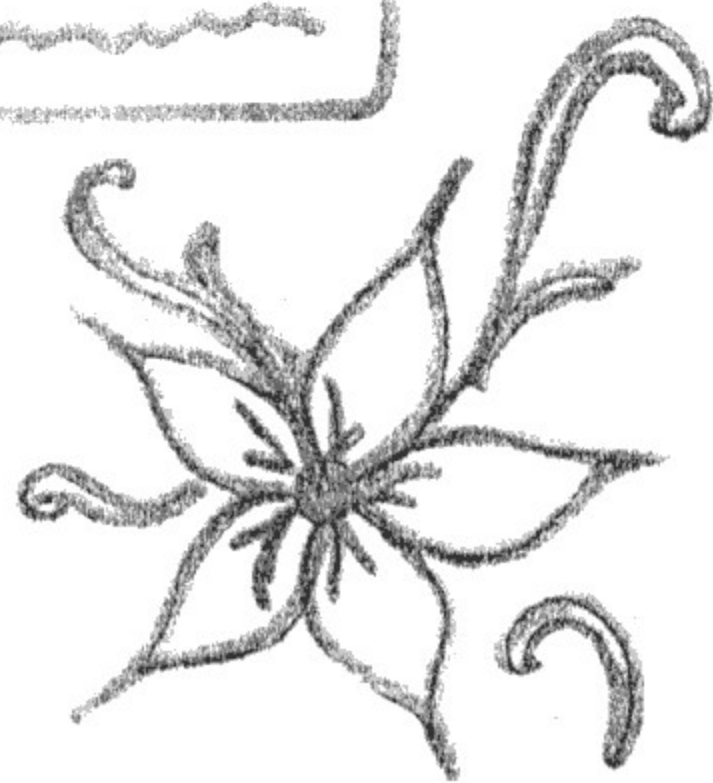

Minutes of the special combined meeting of the Parent Teacher Association of Primary, Secondary and Higher Secondary Section.

Minutes of Special combined meeting of Parent Teacher Association. Regarding the fee hike.

A special combined meeting of the Parent Teacher Association of Primary, Secondary and Higher Secondary Section was held on 1st October 2022 at 1.p.m in the Dr. Dadasaheb Ketkar Sabagriha (Engg. College Auditorium) in the 'dyanagari Campus. The Chairman of the Parent Teacher Association of Secondary Section, Principal Mrs Meena Rane and Chairman of Pre-primary and Primary section, Principal Mrs. Anupama Gujarathi presided over the meeting.

The business transacted at the meeting was as follows:-

> Welcoming the members of the Parent Teacher Association.

Mrs. Deepali Kelkar the teacher's representative of Secondary section, welcomed the chairman of Secondary and Higher Secondary Section Mrs. Meena Rane and the chairman of Pre-Primary and Primary section Mrs. Anupama Gujarathi, members of the parent teacher association and invitees - for the second special parent teacher association meeting for the academic year 2022-23 and then requested the chairman of Pre-Primary and Primary Section Mrs Anupama Gujarathi to

proceed with the meeting.

2) Confirmation of the minutes of the previous meeting.

The Chairman Mrs. Anupama Gajjarathi told the parents that the minutes of the first meeting which was held on Saturday 16th July 2022 were already sent to all the parents by email. She asked the parents that whether they all had received it and then with their consent confirm the minutes of the previous meeting which was held on 16th July 2022.

3) Information about the activities of the school.

- 1) The Secretary of the Parent Teacher Association Mrs. Lalita Mahajan informed the parents about the activities held in the month of July, August, and September 2022 in the Primary section.
- 2) The English Handwriting Competition was held on Monday 18th July 2022 in the first two periods.
- 3) The 1st Term Formative written Examination was conducted from 5th August 2022 to 13th August 2022.
- 4) This year we celebrated our 76th Independence Day "Azadi Ka Amrit Mohotsav" with great enthusiasm and fervour.
- 5) The Marathi Elocution competition was held on Thursday 18th August 2022.
- 6) Teachers day was celebrated on 3rd September 2022. The school management has organized a lunch for

the entire staff of Mukangan English School & Jr. College Standard X students were appointed as student teachers.

- 7) Students who had qualified for the second round of SIP Abacus appeared for the exam which was held on Sunday 11th September 2022.
- 8) The G.K Olympiad exam for the STD III and STD IV was conducted on 15th September 2022.
- 9) The English Olympiad exam was conducted on 22nd September 2022 for STD III and STD IV.
- 10) The English elocution competition was held on Monday 19th September 2022.
- 11) Celebrating their centennial year, Balshikshan Mandir had organised an inter school story telling competition on 28th September 2022. Master Varad Gholap from STD IV B and Miss Devanshi Wagh from STD IV E took part in the competition.
- 12) The Primary Section Counsellor Mrs. Madhura Kale had arranged a session for the students of STD I to STD IV on the good touch and bad touch. To create an awareness among the students on how to be careful and alert when they come across strangers. This was done using pictures, posters and few demonstrations on self defence to educate the children.
- 13) VU Legal Aid Clinic of Vishwakarma University had conducted an awareness programme for the students of STD III and STD IV regarding issue of cyber bullying, online fraud, pitfalls on digital.

* The Achievements of our Principal, Teachers and Students.

The Best Teacher award-for-the year 2022 was given to our Principal Mrs. Anupama Gujarathi, Supervisor Mrs. Rekha Bali and a senior teacher Mrs. Swati Mahajan by International Institute of Hotel Management in association with International Hospitality Council (IHC) London on Saturday 24th September 2022.

Mrs. Kalyani Kulkarni and Mrs. Pallavi Deshpande received the participation certificate for "Essay Competition" organized by Bal Shikshan Mandir.

Master Vihan Bajirao Shinde of std III D received a gold medal on 23rd July 2022 in Thai Boxing which was organized by Thai Boxing Association of Latur. He also received a gold medal organized by Maharashtra Thai Boxing Association at Shirdi on 17th September 2022.

Master Rudra Mahendra Sancheti of IV E won a silver medal for multilevel SIP Poodigy contest.

4) Discussion on the proposal for the fee hike for the next academic year 2023-2024.

The Chairman Principal of Secondary and Higher Secondary Section Mrs. Meena Rane gave information to the representatives about hike in the school fees. She explained to them that the school is allowed to have 30% of fee hike after

every three years, but Mukangan school does not do so. We raise the school fees by 15% every alternate year. So that it does not create a financial burden on the parents. The last hike in the school fees was done in the year 2018-19.

In the year 2019-20 the proposal for the fee hike was sanctioned by the Parent Teacher Association members of that year but due to pandemic in 2020, no fee hike was implemented. She also informed the members that in year 2020-21 the fees were reduced by 15% considering the pandemic situation, the same reduced fee structure was continued for the year 2022-23 when school began physically. So there was no fee hike for the past 5 years. She further said that all the parents would agree for the rise in fees as it was very necessary for the governance of the school, maintenance and salaries of the school staff.

This fee hike proposal was unanimously approved and sanctioned by all the PTA members of Primary Section and Higher Secondary Section.

5) Discussion on any other subject with the consent of the Chairman.

1) Mrs. Priyanka Kharat parent representative of STDIC had suggested to take more writing practice for the students before the formative written examination. Chairman Mrs. Anupama Gujarathi replied that the handwriting competition was conducted, also homework has been given to students. She added that we have writing period once in a week. Other parent teacher association representative shared their views by saying it is also equal responsibility of the parents to take efforts for solving the child's writing problem.

2) Mrs. Sonali Waskar P.T.A of STD IE said that parents are requesting to send home work and class work daily on whatsapp. The chairman Mrs. Anupama Gujarathi replied that students should have writing practice. If we send the home work or class work on the whatsapp group the students will not have writing practice, so she suggested not to form any whatsapp group and not share any writing content.

3) Vice chairman of Mata Palak Mrs. Smita Sawant from ITD informed about the students misbehaviour. The Chairman Mrs. Anupama Gujarathi replied that the reason for this is that children are more exposed to electronic gadgets. She also informed the parents that the school counsellor Mrs. Madhura Kale and all the other teachers are taking care and trying to solve behavioural issues.

6) Vote of Thanks

The Secretary of the Parents Teacher's Association of Secondary Section Mrs. Deepali Kelkar asked the Mata Palak secretary of Primary Section Mrs. Shirin Akolawala to propose the vote of thanks. The Mata Palak Secretary Mrs. Shirin Akolawala proposed the vote of thanks and the meeting ended with a cup of tea.

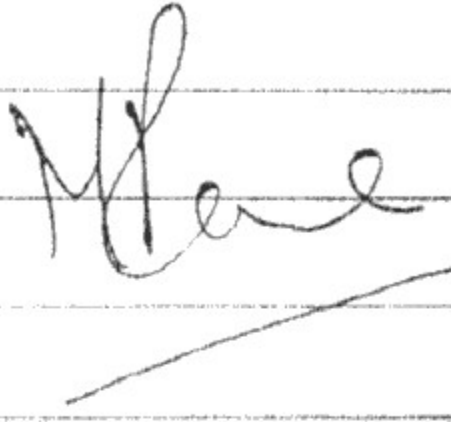
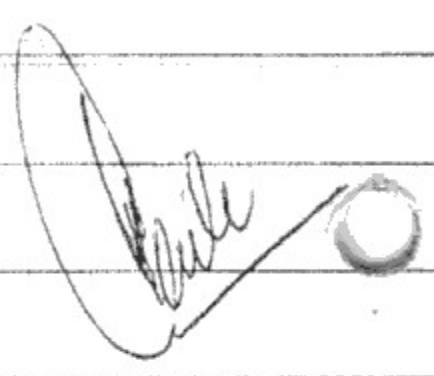
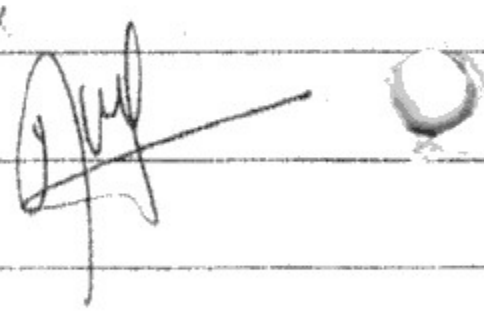
